Any firearms not picked up by 12:00PM NOON Wednesday, September 11th, will be dropped off at a local FFL dealer and you will be required to pick up there with additional fees charged by the FFL dealer. FIREARMS TERMS

Alabama Residents: if you are of age (18 for long guns & 21 for handguns), have a current Carry Permit, OR, an Alabama Photo ID and are legal to purchase and own a firearm under current Federal, ATF and State rules, then you will be required to sign an affidavit stating as such. You are purchasing these from the estate and no additional paperwork is required, and you will take delivery at the auction pickup site on Wednesday, September 11th, 2024. All firearms will be delivered by seller to pick up site on pickup date only. Purchasers must remove on pickup date during the allotted times or firearms possession will be transferred by the estate to a local FFL dealer and you will be required to pick up there with additional fees charged by the FFL dealer.

OUT OF STATE RESIDENTS: you are required to make full payment at close of auction. Then at your expense they will be shipped from local FFL dealer to an FFL Dealer in your state. That FFL Dealer will then run required paperwork before delivery to you and will be subject to additional fees. NOTE: this applies to long and handguns! ***This service is also available for legal Alabama residents who wish to have their firearm(s) shipped to them at their expense. Any shipped firearm is subject to required paperwork and processing through FFL dealer transfer, and all expenses are at the cost of the buyer - including shipping.
